

2.3 Intended use

2.3.1 Areas of application

The electronic accessory set is required for the power supply and the control of electronic WC flush plates for Prevista.

2.4 General notes






Fig. 1: Connection diagram, mains adapter, WC flush plate for Prevista

- 4 WC flush plate for Prevista






Fig. 2: Connection diagram, mains adapter, WC flush plate for Prevista


Extension cable (model 8352.690)

2 metre cable for the extension of the power supply.



Use a maximum of two extension cables with the mains adapter (4.75 meter total length).






Connection cable (model 8570.55)

3-meter cable for external flush actuation with on-site and commercially available buttons with closing function or potential-free contact (closing period 350 ms).



Extension cable adapter (model 8580.49)

For connection of a radio receiver.



WC remote flush actuation (models 8640.1 and 8641.1)

For electronic remote flush actuation on Prevista concealed cisterns.



Cap (model 8655.12)

Protects the connection cable when the electronic accessory set is used with a manual (non-electronic) WC flush plate.



3 Handling

3.1 Assembly information

3.1.1 Mounting conditions

Installation position of the mains adapter

The mains adapter should be mounted in an easily accessible place to allow subsequent access.

Before beginning to clad, a concealed socket should be installed for the mains adapter with conduit pipe to the cistern (installation set & 'Optional accessories' on page 10).

If necessary, the mains adapter cable can be extended to a length of 4.75 metres (two extension cables % 'Optional accessories' on page 10).




Fig. 3: Installation position of the mains adapter

X1 max. 0.75 m

X2 max. 2.75 m with an extension cable (article number 628 505)

X3 max. 4.75 m with two extension cables (article number 628 505)



An extension of the mains supply by more than 5 metres can lead to a situation in which the power is not sufficient to actuate the flush.

Protected zone






Fig. 4: Protected zones

According to the applicable regulations, installation of the mains adapter in the protected zones 0 and 1 of shower rooms and bathrooms is not permitted, see & Chapter 2.1 'Standards and regulations' on page 5.

Viega recommends installing the mains adapter outside of the protected zones 0–2.

3.1.2 Required material and tools

3.2 Assembly

3.2.1 Mounting with flush plate in front position


3.3 Commissioning

3.3.1 Setting the flush






The smallest possible flush volume must be set at the drain valve in the cistern.



■ The small flush volume is set incorrectly.



■ The small flush volume is set correctly.





Do not remove the protective cover of the DIP switches.




The flush volume is set via the DIP switch of the drive unit.



Make the settings only in the currentless (unconnected) state.





- A Setting the flush volume
- B Interval of the Hygiene function
- C Setting the flush volume of the Hygiene function
- 0 DIP switch position: OFF
- 1 DIP switch position: ON

The assignment of the DIP switches:

- Switches 1-4 define the flush volume.
- Switches 5-7 define the interval of the Hygiene function.
- Switch 8 defines the flush volume of the Hygiene function.



The set interval of the Viega hygiene function will only be reset if a large flush volume is triggered.

3.4 Errors, faults and remedy



In case of malfunctions, disconnect the model from the power supply and reconnect it after one minute.



Error	Cause	Solution
The WC does not flush.	The cistern is not yet completely full.	Wait until the cistern is sufficiently full.
	There is no water in the cistern. The corner valve is closed.	Open the corner valve.
The WC flush runs through.	The seal at the filling valve is dirty or damaged.	Check the seal, replace if necessary.
	The seal at the drain valve is dirty or damaged.	Check the seal, replace if necessary.
The WC flushes uncontrollably.	The DIP switches of the drive unit are not set correctly.	Check the setting of the DIP switches, correct if necessary \$\oints\$ further information on page 25.

3.5 Disposal
